TREASURER'S REPORT

 Mr. Sullivan read the Treasurer's Report, dated July 28, 2016. A motion was made by Mr. Trauger, seconded by Mr. Guagno to approve the Treasurer's Report of - \$190,331.96 (Pennland Farms - \$9,839.31 Estates at Deep Run Creek \$5,925.19). The motion passed with a 4-0 vote.

ENGINEER'S REPORT

Authority Projects

The Authority's Engineer generally reviewed the projects within the written engineering report with the Board.

- Elephant Road WWTP Upgrade Construction is in progress. Staff is working with MGK to complete the Time Extension Change order. The delay and time extension is due to equipment delivery issues.
- 2. Stonebridge Sanitary Sewer Replacement Project Mr. DiGangi provided an update to the Board on the progress of the project. Paving is tentatively scheduled for the week of August 2, 2016.
- 3. Deep Run WWTP Decommission Study Mr. DiGangi provided an update to the Board on the progress of the project. Mr. DiGangi discussed the PA Small Water & Sewer Grant with the Board. A motion was made by Mr. McKay, seconded by Mr. Trauger to proceed with the application to the PA Small Water & Sewer Grant. The motion passed with a 4-0 vote.
- 4. Cliffside Manor The preconstruction meeting was held.
- 5. Pennland Farms Phase II Received revised plans for the project. The revision to the plans changes Lot lines. The Authority engineer will provide review comments to the developer.
- 6. Weiss Markets Mr. DiGangi met with Weiss Markets to discuss the project and revised plan submissions.
- 7. Stonebridge Sanitary Sewer Replacement Project A motion was made by Mr. McKay, seconded by Mr. Trauger to approve payment application #3 in the amount of \$99,273.16, payable to Jaoa & Bradley Construction, Inc. The motion passed with a 4-0 vote.
- 2. BMA Elephant Road WWTP Upgrade A motion was made by Mr. McKay, seconded by Mr. Trauger to approve payment application #3 in the amount of \$86,048.64. The motion passed with a 3-0 vote Mr. Guagno recused himself from the vote.

- 1. Lab Testing Mr. Sullivan updated the Board on the issues with the Lab Testing and inconsistent results and reporting. Mr. Sullivan is working with the Lab to resolve the issues.
- 2. Flow Meters Mr. Sullivan provided a brief review of the flow meters installed on the collection system.
- 3. Actuators Mr. Sullivan updated the Board on the issues with the actuators at the Elephant Road Plant and proposed corrective action.
- 4. Budget Process Mr. Sullivan discussed the Budget process with the Board. Mr. Sullivan will work with Mr. Bender and staff to complete the 2017 Operating Budget.
- 8. Neptune Meters Reading Proposal Mr. Sullivan briefly reviewed the proposal for new handheld units. The current units are no longer supported. The proposal details cost for a new handheld unit, cradle and belt clip. The Board directed the Authority Administrator to include the cost in the upcoming budget.
